ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2023 THROUGH JUNE 30, 2024 BY  
ESTIMATING FUNDS FOR OPERATIONS OF CITY GOVERNMENT.**

**WHEREAS**, the City Council has reviewed such budget proposal and accepted same as presented;

The annual budget for the fiscal year beginning July 1, 2023 and ending June 30, 2024 is hereby adopted as follows:


